Asphalt Project

Updated July 26th, 2023. – Changes in Schedule in Red

All dates are subject to weather conditions.

US Post Office mail and packages will be held for pickup **throughout the duration of the project by building.** **Mail Pickup Location:** Bloomington Post Office at 6101 West Old Shakopee Road. Mail and Packages held at the post office for pickup will be delivered with next delivery date on the schedule.

Please review the Schedule carefully for your location:

- **Building 4, 11001 – 11023 Oregon Avenue**
 - July 24th through August 3rd - US mail will be held for pickup.
 - August 4th - US Post Office delivery will resume as normal.
 - **August 4th - Parking restrictions lifted. Entry barricades removed.**

- **Buildings 5 & 6, 11025 – 11087 Oregon Circle**
 - July 24th through **August 5th** – US mail will be held for pickup.
 - **August 3rd - The 2nd and final layer of asphalt will be applied on Oregon Circle. This is a week earlier than the original plan.**
 - **August 7th - US Mail Delivery will resume as normal. Mail not picked up will be included in your first delivery.**
 - **August 7th - All driving and parking restrictions lifted. Barricades at the entrance removed.**

- **Buildings 1, 2, & 3, 7001 – 7071 West 110th St. Circle**
 - August 1st – Asphalt tear out. Flyers will be posted in the next few days with more details.**
 - All cars must be off the property by 7:00 AM**
 - On-street parking available on West 110th, St. – Katun vacant parking lot, and Oregon Ave S.**
 - August 1st, through August 12th - US mail will be held for pickup at the Bloomington Post Office.**
 - August 10th - The final 2” layer of asphalt applied.**
 - **August 14th- US Mail Delivery will resume as normal. Mail not picked up will be included in your first deliveries.**
 - **All driving and parking restrictions will be lifted. Barricades at the entrance will be removed.**

With the change in schedule, and the accommodation made by the US Post Office, mail delivery will be held throughout the construction phases at each building. It will return to normal when parking restrictions are lifted. US Post Office intends to include the mail not picked up in the first delivery.

Carriers, such as Amazon, UPS, and Fed Ex will make their own determination whether to walk in the delivery or hold it. When possible, Homeowners and Occupants should arrange to have their packages delivered to an off-site location during restricted days. *Cub Foods has Amazon lockers, accommodating up to a certain size package. When ordering from Amazon, it will tell you if the Amazon lockers at Cub are available as a delivery option.*
